The purpose of the Citizens Advisory Teams is to create a forum to exchange information between DCTA, its passengers and the community on transit related issues including marketing activities, bus operations, fares and passenger amenities. Through this collaborative effort, the Citizens Advisory Teams are expected to:

- Increase public participation in the functions of DCTA.
- Assure accountability of the organization's actions.
- Act as an education arm of the organization to the public.
- Act as a focused, educated form of public input and feedback to the organization.
- Be representative of a wide range of stakeholders and transit services.

Citizens Advisory Team members will serve two-year terms and are selected by the president based on applications received. Membership shall reflect DCTA's service area and strive for broad, inclusive and diverse representation to increase the reach and effectiveness of its purpose. At least one-half of the members of each team must be users of the service. Applications are available online or by mail.

While these teams are encouraged to meet at least quarterly, the frequency of the meetings are set annually by each team. All meetings will be held in locations accessible by public transportation.
