**Denton County Transportation Authority to Host “Mouthwatering Wednesdays”  
Food Truck Events at its Downtown Denton Transit Center**

*Food truck fans encouraged to come out for lunch and chow down starting January 22, 2014*

**Lewisville, TX (January 14, 2014)** - The [Denton County Transportation Authority](#) (DCTA) will host “[Mouthwatering Wednesdays](#)” food truck lunchtime events starting Wednesday, January 22, 2014 at DCTA’s Downtown Denton Transit Center (DDTC). This is the first of five weekly food truck events that DCTA and Gabriel Kirkpatrick, Owner/Operator of the [Lean Machine food truck](#), have planned for the Denton community.

Last summer, DCTA hosted its first set of food truck events as part of a pilot program. The food truck events were a huge success, and the agency wants to bring back this fun lunchtime dining option for DCTA passengers and the Denton community. Participating food trucks will vary each week and will be limited based on space availability.

“Mouthwatering Wednesdays” will take place from 11 a.m. to 2 p.m. at the DDTC on the following days:

- Wednesday, January 22
- Wednesday, January 29
- Wednesday, February 5
- Wednesday, February 12
- Wednesday, February 19

Each event will feature three local food trucks that will rotate each week. [The Lean Machine](#), [Pickled Carrot](#) and [Shitake Swerve](#) food trucks will kick off the first “Mouthwatering Wednesdays” event on January 22. DCTA and Kirkpatrick will announce future food truck participants via social media.
